# Selected Explanatory Notes to the 3rd Quarter Financial Statements

For the period ended September 30, 2022 (Un-Audited)

- 1 Status of the Company: The Company was incorporated in Bangladesh as a Public Company Limited by Shares on the 27th day of December, 2001 under the Companies Act, 1994. It is noted that the name of Sears Insurance Company Limited has been changed to Takaful Islami Insurance Limited under the provision of Section 11, Sub-Section (5) Act (VII) of 1994. The Company, within the stipulations laid down by Insurance Act 2010 and directives as received from Insurance Development & Regulatory Authority (IDRA) time to time, provides non-life non-life Insurance services.
- 2 Basis of Preparation: 3rd Quarter Financial Statements have been prepared based on Bangladesh Accounting Standard (BAS) 34: "Interim Financial Reporting" and in accordance with other Bangladesh Accounting Standards (BAS), the companies Act 1994, the Insurance Act 2010, Securities and Exchange Rules 1987 and other applicable laws and regulations.
- 3 Accounting Policies and Method of Computations: Accounting policies and method of computations followed in preparing 3rd Quarter Financial Statements are consistent with those used in the annual Financial Statements, prepared and published for the year ending December 31, 2021.
- 4 Gross and Net Premium Earned: During the 3rd Quarter ended September 30, 2022, Company earned gross and net premium Tk, 465.90 and Tk, 332.31 million as against Tk, 445.29 and Tk, 256.50 million respectively for the corresponding same period of the previous year.

5 Earnings per Share(Basic): Earnings per share has been calculated based on weighted average number of share outstanding for the period ended September 30, 2022. Weighted average number of shares outstanding as at September, 2022 was 4,25,86,977.
